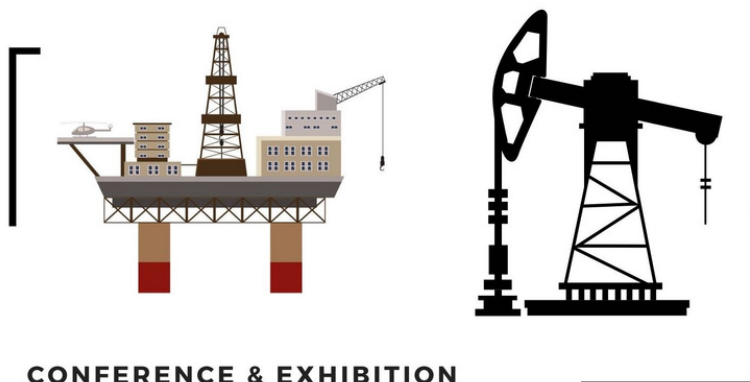

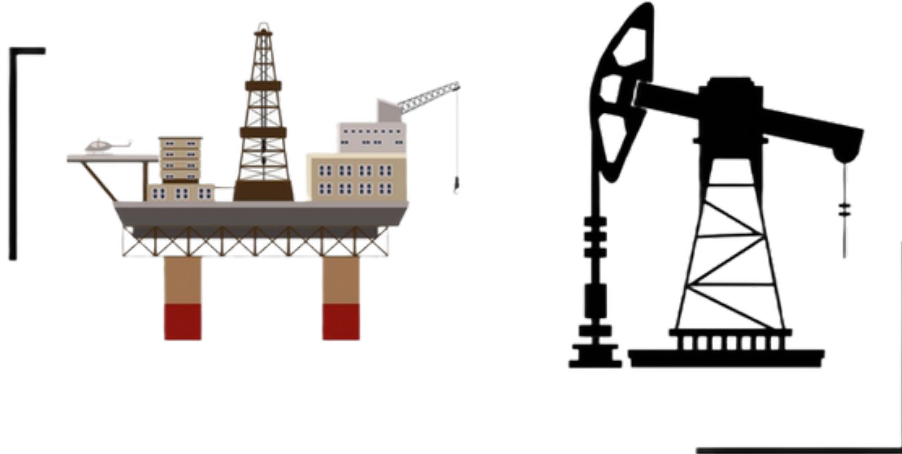
The global challenge in asset management is the safety of everyone who interacts with the assets. Strong leadership is critical to the success of any safety initiative.
